### EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013:

#### Item No. 1:

The Board appoint Mr. Rabi Prakash Sharma as a Manager for a period of five years with effect from 06.12.2024 in their meeting held on 06<sup>th</sup> December 2024 subject to the approval of the shareholders within 3 months from the date of appointment as per Regulation 17 & 25 of SEBI (LODR) 2015.

The Draft agreement between the company and Mr. Rabi Prakash Sharma contains the following terms and conditions.

- I. Mr. Sharma shall hold the office of the “**MANAGER AND VICE PRESIDENT (WORKS)**” of the company with effect from 06<sup>th</sup> December, 2024 for the period of 5 years and shall (unless prevented by ill health or accident or by reason on leave) through the said (except with the consent of the board) devote the whole office time attention to the business & affairs to the company and shall comply with all the direction from time to time be given by the board & shall in all respect & confirm & regulation made by the board and shall well faithfully serve the company & use his uttermost endeavors to promote the interests thereof.
- II. Mr. Sharma shall be entitled to exercise such powers on behalf of the Company as may from time to time be lawfully entrusted to and confirm upon him by the Board either alone or jointly with any person(s) as the board shall be determined.
- III. In consideration of Mr. Sharma's service as the “**MANAGER AND VICE PRESIDENT (WORKS)**” of the Company he shall be entitled to receive the following remuneration and benefits :-
  - a) Salary : Rs. 90,200/- per month.
  - b) House Rent Allowance : 25% of Basic Salary



# Six years after quota for women at IITs, changes are quite visible

FROM MORE HOSTELS and washrooms for female students to their own sports teams — a silent revolution has been taking shape at the Indian Institutes of Technology (IITs) over the last six years, ever since a supernumerary quota of 20% was set aside for women.

The quota, under which extra seats were created instead of reserving them in the existing pool, was implemented in 2018 based on the recommendations of a committee led by then IIT-Mandi Director Timothy Gonsalves, which called it “the required slight push”. While most IITs implemented a 14% quota for women in 2018-19, by 2019-20 it stood at 19% and by 2021-22, most of them had 20% seats for women.

Six years on, data obtained by The Indian Express under the Right to Information (RTI) Act from 21 of the 23 IITs reveals a steady increase in the number of women entering these prestigious institutes.

At IIT-Kanpur, the number of women rose from 908 women in 2017 to 2,124 in 2024 — a 133% jump. At IIT-Roorkee, the number went up from 1,489 in 2019-20 to 2,626 in 2024 — a 76.36% jump. IITs in Chennai, Mumbai, Guwahati and Kharagpur, too, saw similar increases.

According to the data, IITs Delhi and Bombay crossed the 20% threshold as early as 2017 — even before the quota was implemented. Of IIT Delhi’s 2,878 students that year, 607 or 21.09% were women. In the first semester of 2024 at IIT Delhi, that number stood at 840 — a rise of 38.39%. In the case of IIT

Bombay, of 2,790 students in 2017, 570 or 20.43% were women.

Meanwhile, IIT Kanpur was the last among the seven first-generation IITs to cross the 20% female enrolment mark, reaching the milestone only in 2021. Of its 7,716 students that year, 1,691 or 21.92% were women.

Like IIT Kanpur, other first-generation IITs too achieved this benchmark at varying speeds. IITs Guwahati, Kharagpur and Madras joined the ranks in 2019, with female representation of 22.42%, 21.39% and 20.75%, respectively. IIT-Roorkee followed suit in 2020, where 1,749 or 20.08% were women out of 8,708 students.

A changing classroom The increasing presence of women at IITs is in line with the broader pattern of a steady increase in their enrolment in higher education — according

to the All India Survey on Higher Education for 2021-2022, the last year for which the data is available, women make up around 48% of the total enrolment, almost on a par with men.

Yet, given the technical nature of IITs, the gender ratio at these premier engineering institutes continue to be skewed in favour of men. It’s this that the scheme attempts to change, with individual institutes implementing a string of measures to make campuses friendlier for women.

In 2020, IIT Bombay introduced special orientation sessions for girls who had cleared JEE-Advanced and their parents on why they should choose the Mumbai campus. The administration claims that these sessions contributed to more girls choosing IIT Bombay — from 570 in 2017 to 694 in 2024. The year 2021 marked its highest ever

female enrolment of 746.

IIT Delhi, too, has an open house for women students and their parents, where they are encouraged to meet faculty and explore the campus.

Preeti Aghalayam, Director of IIT Madras’s Zanzibar campus — the first woman to serve as director at an IIT — says that when she did her chemical engineering from IIT Madras between 1991 and 1995, the percentage of women in her undergraduate class was “extremely small”.

“Back then, the women’s hostel was located far from all the other hostels since the number of women at IIT Madras was minuscule. The campus looks and feels very different now. Class sizes have doubled, classrooms have different perspectives and there is a new energy on campus,” she says. With that, gender sensitisation has become a part of daily institutional life.

Pradeep Srivastava, Associate Professor, Department of Earth Sciences at IIT Roorkee, and a member of the institute’s Internal Complaints Committee, says more women on campus has meant a check on the “male-centric approach”. “Every time there is a case of sexual harassment or ragging, we have observed a progressive change — it no longer starts with blaming the female student,” he says.

Srivastava’s colleague Naveen Kumar, Professor, Department of Biosciences and Bioengineering, and Dean, Academic Affairs, says he ensures he calls his female students to his office “in pairs to ensure a comfortable environment of learning”.

At IIT Roorkee, where four of 13 hostels are allocated to women, the administration has spent nearly Rs 6 crore on security cameras and hired more women guards. “We have

installed over 300 cameras on campus,” says Major Reeti Upadhyay, Deputy Registrar, IIT Roorkee.

A professor from IIT Delhi’s Department of Civil Engineering says he keeps his office door open if a female student wishes to speak with him. “I have adopted a more sensitive approach to teaching now. I don’t scold girls as much when they make mistakes because I feel uncomfortable if they start crying,” he says.

The growing female presence has also meant a new sports culture — both IIT Delhi and Bombay have their own women’s football teams.

Ravinder Kaur, Professor Emeritus, Department of Humanities and Social Sciences, IIT Delhi, and a researcher on women in STEM, says, “Earlier, the sports grounds were dominated by men, something that deterred girls who wanted to practise or play sports. In the past, men’s hostels were closer to all the activity centres and the ground. Now, at IIT Delhi, women’s hostels have also moved closer to the activity spaces.” At IIT Bombay, gender sensitisation workshops are mandatory for all students and staff, including security personnel, says a student council member. Despite these changes, challenges remain — stereotypes, mentorship gaps and lack of inclusive spaces, among others.

Sarani Saha, Chairperson, Gender Cell, IIT Kanpur, says much remains to be done even now. “Women still don’t come forward to complain about harassment. Despite gender sensitisation workshops, the progress has been uneven. Even after all these workshops, some male professors admit they are unaware how certain behaviours — like comments on attire, etc. — can make women uncomfortable.”

# ‘Bangladesh crisis offers new opportunities for Indian textile clusters’

AMID THE ONGOING economic and political tensions in Bangladesh, Indian exporting firms, particularly in the Tirupur clusters, are receiving higher enquiries from several global apparel brands, including Primark, Tesco, Decathlon, Dunelm, JCPenney, GAP, Next, and Walmart, with order conversion expected for shipment by early 2025, Mithileshwar Thakur, Secretary General of the Apparel Export Promotion Council (AEPCC) said.

Due to a record surge in the US dollar’s value, Bangladesh has faced a sharp depletion in its foreign exchange reserves, which fell below \$40 billion for the first time in two years in July last year. With foreign exchange reserves sufficient to cover only four to five months of imports, Bangladesh has faced challenges in importing cotton and fabric, which it traditionally sources from India. This comes amid tightening economic conditions in the neighbouring country.

“This crisis also presents an opportunity for additional employment generation. Capturing just 10 per cent of Bangladesh’s global apparel exports could directly create 5,00,000 jobs and indirectly generate an additional 1 million jobs in the Indian apparel sector. To seize the opportunity presented by this development, India needs to urgently address issues related to capacity augmentation and skill development,” Thakur said. Most European brands sourcing from Bangladesh, particularly in the cost-sensitive segment, are facing challenges in immediately shifting orders to alternative destinations, due to the distinct cost advantages offered by the country, such as low wage rates, duty-free access, and its Least

Developed Country (LDC) status. However, several prominent brands have decided not to further increase their exposure to Bangladesh for sourcing, Thakur added. Notably, Bangladesh enjoys a 10-15 per cent cost advantage over India, as its apparel products benefit from duty-free access in the European Union, the UK, and Canada due to its LDC status.

India can only bridge the duty disadvantage after it signs a free trade agreement with the EU and the UK. Currently, several Indian manufacturers have set up factories in Bangladesh due to India’s labour laws, concerns about unions, and the cost disadvantage.

Thakur further said that global investments are driven by the political stability index, and the continued instability in Bangladesh presents a significant opportunity for India to attract investments that might otherwise flow to neighbouring competing countries such as Vietnam, Cambodia, and Indonesia. “However, with a strong focus on improving and

upgrading infrastructure, capacity expansion, technology infusion, and compliance, India is well-positioned to capitalise on these redirected investments. We are also in talks with agencies and consulting firms to engage them in improving productivity and efficiency in the operations of garment manufacturing companies, which can unlock the under-utilised production capacity in the apparel sector,” Thakur said.

On PLI 2.0:

To capture market share and seize the opportunities arising from the reorientation of supply chains due to Bangladesh’s crisis and the China+1 factor, India must act swiftly to enhance its production capacity, shorten production cycle times, and improve speed to market, in addition to focusing on workforce skilling and developing a robust compliance architecture, Thakur said. “Accordingly, the PLI 2.0 scheme for all types of garments, irrespective of fibre, with a reduced investment threshold, should be introduced on an urgent basis. This scheme would foster investment and scale up production capacity exponentially. For micro-industries, the Amended Technology Upgradation Funds Scheme (ATUFS) should be revived for technology upgradation, as PLI 2.0 will not cover micro-industries within its scope,” he said.

On challenges in input material imports:

Thakur stated that due to the unavailability of quality Man-Made Fibre (MMF) fabric from indigenous sources, garment exporters are often dependent on fabric nominated by foreign buyers. He added that the “existing scheme of special advance authorisation” for fabric import is “not suitable for garment exporters”.

# Delhi: Dense fog disrupts flight and train services

FIFTY-ONE TRAINS WERE delayed and several flights rescheduled as dense fog enveloped the national capital on Sunday morning, reducing visibility to zero, officials said.

“Zero visibility prevailed over Palam from 4 AM to 7.30 AM IST, accompanied by easterly winds at 8-13 kmph,” an IMD official said.

“Compared to Saturday’s 9-hour zero visibility spell, Palam experienced a relatively shorter duration of 3.5 hours of zero visibility on Sunday,” the official added.

The maximum temperature in the city settled at 18.6 degrees Celsius, 0.7 notch below the normal average, and

the minimum temperature was recorded at 9.4 degrees Celsius, the India Meteorological Department (IMD) said.

The relative humidity during the day ranged between 83 and 95 per cent, it said. For Monday, the weather department has predicted a generally cloudy sky with a possibility of very light to light rain accompanied by thunderstorms in the morning.

The predominant surface wind is expected to blow from the southeast at a speed of less than 4 kmph during the morning hours. Smog and moderate fog are likely in most places, with dense fog expected in a few areas during the morning.

The wind speed is forecast to gradually increase to 6-8 kmph from the southeast in

the afternoon, before decreasing to less than 6 kmph from the northwest during the evening and night. Smog or shallow fog is likely in the evening and night, it added.

The maximum and minimum temperatures are expected to settle around 18 and 11 degrees Celsius, respectively. In a related development, the air quality in the national capital remained in the ‘very poor’ category.

Delhi’s 24-hour average AQI was recorded at 339, according to data from the Central Pollution Control Board (CPCB). An AQI between 0 and 50 is considered ‘good’, 51 and 100 ‘satisfactory’, 101 and 200 ‘moderate’, 201 and 300 ‘poor’, 301 and 400 ‘very poor’, and 401 and 500 ‘severe’.

# Four Maoists, jawan killed in first Bastar encounter this year

FOUR MAOISTS WERE gunned down on Saturday afternoon in the first encounter this year between Naxals and security forces in Chhattisgarh’s Bastar region. In a subsequent gunfight in the evening, a District Reserve Guard (DRG) jawan was killed.

The encounter took place in Abujhmad, a vast unsurveyed

area that is larger than the state of Goa, and is spread across the districts of Narayanpur, Bijapur, Dantewada, and Kanker in Bastar region, and a small part of Gadchiroli in Maharashtra. Police said the encounter broke out in the trijunction area of Narayanpur, Bijapur and Dantewada districts, but did not specify the exact location. The killed jawan was identified as Head Constable Sannu Karam (34),

who joined the DRG.

Giving details of the encounter, Bastar Inspector General of Police Sundarraj P said, “Acting on the presence of around 40-50 Maoists from Abujhmad (also known as Maad) division, a joint operation was undertaken by DRG teams from Narayanpur, Dantewada, Jagdalpur, and Kondagaon as well as the Special Task Force.”
